- In case if a member does not receive the bill by 10<sup>th</sup> of March and 10<sup>th</sup> of September as the case may be he/she is requested to contact the FBS office at Hyderabad Phone Number 24737496, Time 12.00pm to 4.00 pm or the Secretary of the Local Branch of IMA to ascertain the amount of the bill payable by him and remit the same in time before the last date mentioned to avoid penalty.
- Please pay the Challan (Andhra Bank)/Draft with in one month from the date of issue of the notice, otherwise Rs.25/- per month will be charged extra for the delayed receipt of drafts/challan beyond one month from the date of issue of drafts/challan.
- Please note that late fee of Rs.25/- per month or part there of delay is payable in case of payment made after the due date i.e.30.09.2011
- Mention your telephone number, cell number and change of address if any to this office for further communication.
- Enclose the slip duly filled along with the Challan. Please mention your name & FBS. Number on the Challan.
- Send the Challan copy to FBS office immediately after payment Keep xerox copies of Challan with you for your records.
- A member becomes a defaulter, if he does not pay his contribution within the time specified. No claim will be entertained if member become a defaulter. A defaulter can continue in the scheme by paying the penalty as per the rules existing.
- The actual fraternity contribution amount collected from the members shall be distributed to the beneficiaries. The last beneficiaries FC-39 received Rs.4,60,000/-
